

### 2023 CLMP Report

• 2 years of data collected

### • 2024 Monitoring Parameters

- Secchi Disk (Water Clarity)
- Spring/Summer Phosphorus
- Chlorophyll-a
- Dissolved Oxygen
- Water Temperature

### Annual Funding

 Continue current parameters at approximately \$233/year







### ALPOA Lake Health Committee – Invasive Species

- Lake Plants Survey- History
  - Jo Latimore CLMP Training 2022
  - AuSable Lake Volunteer Survey 2022
  - MSU Survey 2022
  - All three surveys identified Invasive species
- What is an invasive species?
- Invasives found:
  - Curly-Leaf Pondweed
  - Starry Stonewort
- Risks to lake if not addressed
  - Smothers native plants
  - Forms dense beds
  - Impedes boating skiing, tubing, etc.
  - Decline in fish habitats




### ALPOA Lake Health Committee – Invasive Species


- Committee activity
  - Collaboration with Sage Lake Fishing Committee sharing of ideas
  - Met with DNR Biologist for our lake, Matt Klungle
    - Review of past water quality testing, fish surveys, and fish stocking data
    - Review of decision by DNR to stop walleye stocking program for our lake
    - Request from our biologist to collect fish harvest data from persons fishing on our lake to support future changes in habitat, predation and stocking > establish both hardcopy and phone app to collect data
    - Scheduling a tour of our lake with Matt


### Committee Activity

#### Committee Plans

- Habitat improvement
- Launch fishing survey
- Address predation from pike, pike population high and size low
- Do not disturb largemouth bass fishing





#### Future Plans

- Work with biologist and state to seek grant money for habitat enhancement
  - Permits for water structure (trees)
  - Gravel bed for walleye spawning
- Continue to collect fishing harvest data
  - Support from DNR to reduce size limit for pike address predation
  - Do not disturb largemouth bass fishing
  - Restart of walleye stocking program
  - Improve perch (size and population) and black crappie (population) fishing
- Sample water on west side of lake where water enters and exits lake

#### Fish Harvest Data Collection

- Provide hard copy collection, forms being printed and mailbox for collection established
- Provide phone app
